Terms and Conditions

Terms and conditions

These terms and conditions (the **Terms**), as updated from time to time, are intended to govern the PracticeHub EOY 2023 promotion (the **Promotion**). The promoter of this Promotion is MyPracticeManual Pty Ltd ACN 150 460 129 trading as "PracticeHub" (**PracticeHub**). Participation in the Promotion is subject to these Terms.

Overview of the promotion

1. The Promotion is a promotional activity by which Eligible Entrants can receive up to a \$750 discount on PracticeHub set up package (the **Promotion Benefit**) by signing up to PracticeHub in accordance with these Terms.
2. The PracticeHub set up packages include: Lite (basic set up); Standard; Accelerate; or Premium. Eligible Entrants can email PracticeHub on support@practicehub.com.au or call 1300 96 86 36 during office hours for more information on these packages.

Promotion period

3. The Promotion runs from 9:00am AEDT, Monday 2 October 2023 to 5:00pm AEDT, Friday 29 December 2023 (the **Promotion Period**).

Eligibility criteria

4. The Promotion is only available to organisations that purchase PracticeHub (the Purchaser) and are not deemed ineligible in accordance with clauses 4 or 5 below (**Eligible Entrant**).
5. Existing PracticeHub customers are ineligible to enter this Promotion.
6. Directors, management and employees of PracticeHub and its associated entities, and immediate family of existing customers of each of these persons are ineligible to enter this Promotion.

Participation criteria

7. To participate in the Promotion, Eligible Entrants must sign up to PracticeHub within the Promotion Period.

Promotion benefit

8. Each Eligible Entrant that signs up to PracticeHub in accordance with clause 6 will receive the Promotion Benefit.
9. Promotion Benefits will be issued within 48 hours of attending the scheduled online consultation with PracticeHub.
10. A maximum of one Promotion Benefit per Eligible Entrant may be issued to any Eligible Entrant.
11. The Promotion Benefit will be delivered by email. The email address will be the one provided by the Eligible Entrant, PracticeHub will not be held responsible for undelivered Promotion Benefits and no replacement will be provided.

12. PracticeHub shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to direct or consequential loss), or for any personal injury suffered or sustained in connection with any Promotion Benefit, except for liability that cannot be excluded by law.
13. The Promotion Benefit is not exchangeable for cash or credit.
